CERTIFICATION OF THERAPISTS OF THE ZDENKO DOMANČIĆ METHOD OF BIOENERGY THERAPY®

WHAT IS CERTIFICATION?

Certification is a form of control aimed at ensuring fulfilment of minimal requirements for occupational work activity at the basic or specialized level of competence. Certification is a form of support and stimulation of a dynamic development of occupational activity with the purpose of achieving the highest occupational and ethical standards through continued professional training.

Certification for different occupations is gaining more prominence worldwide and more and more countries are turning to this kind of approach in improving the quality of providing different professional services.

There are two general objectives related to any certification procedure:

- assurance of high quality of professional services
- motivation of professional therapists to continue professional development with the purpose of achieving high standards of professional competence.

CERTIFICATION OF THERAPISTS OF THE ZDENKO DOMANČIĆ METHOD OF BIOENERGY THERAPY®

The certification of therapists of the *Zdenko Domančić Method of Bioenergy Therapy*[®] is carried out in relation to control of meeting regulations and standards of performance of the *Zdenko Domančić Method of Bioenergy Therapy*[®]. The certification criteria is related to meeting educational and training standards through programmes (training, practice and performance) for therapists of the *Zdenko Domančić Method of Bioenergy Therapy*[®], i.e. meeting the certification standards through continued professional training of therapists of the *Zdenko Domančić Method of Bioenergy Therapy*[®].

The therapist certification procedure is defined to:

- comply with the authenticity of the method
- ensure quality of therapy in accordance with the teachings of Zdenko Domančić® and with user expectations
- provide help to therapy users in choosing therapists
- protect intellectual property of Zdenko Domančić[®], creator and founder of the method
- avoid promotion and activities of false and incompetent therapists who do not meet the required standards regulated by the Regulations

Certification of therapists of the *Zdenko Domančić Method of Bioenergy Therapy*[®] is a new concept. It relates to the procedure of evaluating and assessing therapists in the Association in order to ensure they comply with the predefined standards of therapists of the *Zdenko Domančić Method of Bioenergy Therapy*[®].

Certification of therapists of the *Zdenko Domančić Method of Bioenergy Therapy*[®] can be obligatory and in that case it relates to compliance with minimum requirements prescribed by the Association for the occupation of therapists of the *Zdenko Domančić Method of Bioenergy Therapy*[®]. Certification can also be voluntary and in that case it relates to compliance with high standards of the profession which are not required by law, but are determined by Zdenko Domančić as founder of the method and the Association of the *Zdenko Domančić Method of Bioenergy Therapy*[®] as professional organization, aimed at stimulating continued professional education and advancement of provision of professional services.
