INTELLECTUAL PROPERTY AND TRADEMARK

The use of the name and trademark Zdenka Domančić® constitutes protected intellectual property. The owner of the intellectual property rights is Zdenko Domančić®, the Domančić® d.o.o. and the use and all activities related to the use of his name are defined by the company Domančić® d.o.o. from Slovenia. Intellectual property law includes a system of legal instruments that regulate the acquisition of intellectual property rights and the way to protect against its unauthorized use. Only authorized individuals and entities under contract can use and benefit from elements of the brand, visual identification, provide training services, conduct refresher workshops, and use informational media that are an integral part of the business. COLLECTIONS FOR STATUTORY ACTIVITIES

EDUCATION, CERTIFICATION, PRACTICING THE METHOD

Therapists without certification - illegal practice. As an association granted permission to operate through Ms. Martyna Fon Zvegelj, you are obligated to uphold the good reputation of the method in Poland, especially in terms of respecting the code of ethics and promoting the method. Individuals who have not completed the entire training program and, consequently, have not undergone the necessary examination procedure for obtaining permission are not therapists of my method but practitioners at levels 1 and 2. Such activity, conducted under the name and surname Zdenka Domančić®, is considered unauthorized by Domančić® d.o.o. and therefore - illegal. The education of therapists is conducted exclusively and only in cooperation with Domančić® d.o.o. and in Poland in agreement with the representative of the method - the training institution Energia Vita Martyna Fon Zvegelj. The education of future therapists is an important and responsible task that cannot be carried out without specialized supervision. Education, refresher workshops, therapeutic practices, internships cannot be organized and conducted by self-proclaimed entities, as it threatens the appropriate level of specialized work, credible education, and the credibility of my method.

EDUKACIJA, CERTIFIKACIJA, PRAKTICIRANJE METODE

Terapeuti bez certifikacije - nelegalna praksa. Kao udruženje kojem je odobrena dozvola za rad putem gospođe Martyny Fon Zvegelj, obavezani ste čuvati dobar ugled metode u Poljskoj, posebno u smislu poštovanja etičkog kodeksa i promoviranja metode. Osobe koje nisu završile cijeli program edukacije i stoga nisu prošle potrebnu proceduru ispitivanja za dobivanje dozvole, nisu terapeuti moje metode, već praktičari na razinama 1 i 2. Takva aktivnost, provođena pod imenom i prezimenom Zdenka Domančića® smatra se neovlaštenom od strane Domančić d.o.o. i stoga - nezakonitom. Edukacija terapeuta provodi se isključivo i samo u suradnji s Domančić d.o.o. i u Poljskoj u suglasnosti s predstavnikom metode - institucijom za edukaciju Energia Vita Martyna Fon Zvegelj. Edukacija budućih terapeuta važan je i odgovoran zadatak koji se ne može provoditi bez specijaliziranog nadzora. Edukacija, radionice, terapeutske prakse, stažiranja ne mogu organizirati i provoditi samoproglašene jedinice, jer to ugrožava odgovarajuću razinu specijaliziranog rada, vjerodostojno obrazovanje i vjerodostojnost moje metode.
